

The following is a brief summary of some of the policies required by the City of Redwood City.

Vendor Restrictions:

REDWOOD CITY CODE 20.211

An additional permit is required for vendors to stay in one position for longer than 30 minutes. The vehicle may park only at the request of a purchaser. After 30 minutes the vendor must move 500 feet or more. The vendor may not return to that prior location within a four (4) hour period.

Hours of Operating:

REDWOOD CITY CODE 20.219

The hours of validity are:

6:00 am—10:00 pm

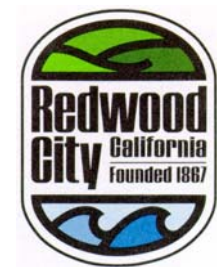

Vendor and Catering Truck Operators

The city would like to welcome you and we look forward to helping you do business within Redwood City. Vendors and catering truck operators must abide by several regulations from Redwood City and San Mateo County to operate in the city. **New applicants and renewals are required to obtain each of the following:**

★ **Photo Identification Permit** obtained at [Redwood City Police Department](#), 1301 Maple Street

All applicants must submit a passport size photo to the Police Department at the initial application.

Police Department accepts application only on **Wednesday** from **1:00 pm to 3:00 pm**.

IMPORTANT NOTICE

▶ All of the items listed previously **must** be obtained prior to conducting business in the city. The blue identification badge **must** be worn when operating the business (**RCC 28.9**). All the regulations previously listed **must** be renewed on a yearly basis.

▶ A receipt is **not** a substitute of the ID permit. (There will be a waiting period prior to obtaining the Police ID.)

Citations may be issued if vendors are

▶ operating their business in the absence of any one of the aforementioned documents. The business **may also be shut down** for any violation of these requirements.
