## GENERAL INFO

The Redwood City Salsa Festival is the third celebration of the redevelopment of Downtown Redwood City. It will feature a competition of professional and amateur chefs in the creation of the best tasting salsa, 3 stages of salsa and latin entertainment, tequila tasting, salsa dance lessons, family activities, microbrew and wine booths, fine arts and Redwood City restaurants.

## SCHEDULE & LOCATION

- Festival Hours: Saturday, September 26, 2009, from noon to 8 p.m.
- Festival will take place on 8 blocks of downtown Redwood City.

## SETUP & BREAKDOWN

- Setup starts at 7:00 a.m. - All vendors must have their vehicles off the set-up area by 11:00 a.m.
- Breakdown must begin at 8:00 p.m.
- No early departures.

## BOOTH PROVISIONS

- 10' x 10' booths will be provided for food vendors.
- One 20-amp circuit is available for each food vendor if required at no extra cost
- Water and individual trash cans will not be provided.

## RESPONSIBILITY

Labadie Productions and the City of Redwood City, assumes no responsibility for any loss, damage, injury or claim arising out of the participants' acts or omissions at the Redwood City Salsa Festival, the applicant hereby agrees to hold the City of Redwood City their Directors and Members, and Labadie Productions harmless from any claim arising out of the applicant's entry, acts, or omissions in said festival or any accident, injury or damage involved therein, including but not limited to attorney fees and court costs.

## OPERATIONS

- The committee will make all placement decisions for vendors for the good of the festival.
- There will be absolutely NO REFUNDS.
- Each vendor is responsible for their own insurance, licenses, and permits.
- Food vendors will be sent a health department application. We will assemble and distribute health permits.
- All vendors who are required to have resale numbers are responsible for collecting sales tax. Tax numbers must be included on application.

## BOOTH RESPONSIBILITIES

- All safety and fire regulations must be observed.
- Each vendor is responsible for the condition of their space during and after the event. If area is not clean at the end of the event, the cleaning deposit will not be returned

## APPLICATION INFORMATION

### WHAT TO INCLUDE:

- **Completely filled out application. Incomplete applications will not be considered.** Be as specific as possible on description of food items.
- Payment in full via paypal, check, money order, or cashiers check.
- Payment must include booth fee and health department payment.
- **Applications will not be considered unless payment is included.**
- Cleaning deposits will be returned within two weeks.

## ACCEPTANCE/SPACE ASSIGNMENT

- Food Vendors space location will be first come, first served per the **postmark** on the application. Redwood City Restaurants will be considered first.
- Space assignments and package with directions, Festival rules and regulations, etc., will be mailed on or before **September 8. Keep this packet, you will need it on the day of the festival.**
- If you have not been accepted into the festival, your payment will be returned with your non-acceptance letter.
