SUBJECT

Civic Cultural Commission Year-end Transfer to Public Art Fund

RECOMMENDATION

By resolution, approve the transfer of the remaining balance in the Fiscal Year 2008-2009 Civic Cultural Commission program budget into the City's Public Art Fund.

BACKGROUND

At their May 7, 2009 meeting, the Civic Cultural Commission unanimously voted to ask for Council approval to transfer the remaining balance of their budget to the City's Public Art Fund. The Commission established the Public Art Fund so they could accumulate funds towards the purchase of a piece of public art for Redwood City. The Commission has a current budget balance of \$14,561.80 for Fiscal Year 2008-2009 and does not anticipate other expenses this fiscal year. The current balance of the Public Art Fund is \$18,085.00.

No decisions on the use of the City's Public Art Fund are associated with this request, and the Civic Cultural Commission will return to Council with any request to use the Public Art Fund to obtain their input and approval.

ALTERNATIVES


The Council could choose not to approve the transfer, in which case funds would roll into the ending balance for the General Fund on June 30, 2009.

FISCAL IMPACT

Funds totaling \$14,561.80 are currently in the Civic Cultural Commission budget. If Council approves the transfer, the balance of the Public Art fund will be \$32,646.80 on July 1, 2009.

**RESOLUTION TRANSFERRING THE SUM OF \$14,561.80 FROM
THE REDWOOD CITY FY 2008-2009 CIVIC CULTURAL
COMMISSION FUND TO THE REDWOOD CITY PUBLIC ART FUND**

WHEREAS, the Civic Cultural Commission established the Public Art Fund to accumulate funds towards the purchase of a piece of public art for Redwood City; and

WHEREAS, the Commission budget has a current balance of \$14,561.80 for Fiscal Year 2008-2009 and has no other expenses to be paid; and

WHEREAS, the Commission voted unanimously to ask for approval to transfer the remaining balance in its budget into the Public Art Fund.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE
CITY OF REDWOOD CITY, AS FOLLOWS:**

1. That the budget for fiscal year 2008-2009 is amended to appropriate the sum of \$14,561.80 from the Civic Cultural Commission budget to be allocated to the Public Art Fund (357-71393-95).
