Participating BAWSCA Agencies offer up to a \$150 rebate when you upgrade your old toilet using 3.5 gallons per flush (GPF) or higher to a new, high-efficiency model.

A toilet using 3.5 GPF or more accounts for roughly 26% of your home's indoor water use. One of the easiest ways to lower your toilet's water use by approximately 62% is to install a high-efficiency toilet (HET), which uses on average 1.3 GPF or less. Although HETs use less water, they remove waste effectively and perform well.

High-Efficiency Toilet Rebate Program Eligibility Rules

- The HET Rebate Program only rebates the replacement of toilets using 3.5 GPF or more. *You must replace a working toilet flushing 3.5 gallons per flush or higher to receive a rebate.*
- No standard 1.6 GPF toilets qualify for a rebate.
- Toilets must be purchased between January 1 and June 30, 2009. Toilet installation and rebate application postmark must be completed within 90 days of purchase date.
- Original receipt(s) must be sent with application.
- The exact tank and bowl model number of the toilet you purchase must be on the List of Qualifying Toilets for your water agency on the day of your purchase. An updated list of qualifying toilets will be posted at www.bawasca.org during program period.
- Rebates are **\$150** per toilet or up to the total cost (not including sales tax), whichever is less.
- **Limit:** Three rebates per living unit, not per account. Ten rebates per commercial account.
- If you need your original receipt(s) returned, please enclose a self-addressed, stamped envelope with your application.
- A pre-purchase inspection and post-installation inspection are required for any site where seven or more toilets are being replaced.
- All sites are subject to post-install inspections.
- New construction or bathroom improvements made after 1993 do not qualify.
- A separate application must be submitted for each metered address.
- Approved toilets must be installed within the service area of your water agency.
- All rebates are subject to availability of funds. Rebates may take up to eight weeks to process.
- Rebates are issued as checks or issued as credits on water service account.
- Applicant certifies that necessary permissions have been obtained from the property owner, if applicant is not the owner.

Application Checklist

- Did you check that your old toilet meets eligibility rules?
- Is the **EXACT MODEL NUMBER** of the toilet you purchased on **YOUR WATER AGENCY's** List of Qualifying Toilets?
- Did you include your water service account number on the application?
- Have you completely filled out & signed the application form?
- Did you enclose the original receipt and the toilet rebate application?
- Did you provide a tax ID or social security number?
- Did you install your HET and mail in the rebate application within 90 days of purchase?
