

Project: The draft Specific Plan propose standards and guidelines for development of the Inner Harbor area, implementing Redwood City’s 2010 General Plan. The Draft Environmental Impact Report (EIR) examines the potential environmental effects of the overall specific plan and the project-level impacts of the proposed Harbor View Place development within the Specific Plan area and containing one additional parcel outside the Plan area. Specific Plan: The proposed Specific Plan governs the 100-acre Inner Harbor Area and provides for the following elements:

- Land use policies and designations, zoning and development standards
- Urban and landscape design guidelines and standards
- A framework for circulation and parking improvements, including new and improved roads and pedestrian and bicycle networks
- A framework for utilities improvements, including water, recycled water, stormwater and sanitary sewer, and gas and electric infrastructure
- Measures to address risks associated with sea level rise
- Policies and measures to ensure that existing view corridors will be considered during detailed site planning.

Harbor View Place: Jay Paul Company proposes to develop a 26-acre area designated "Inner Harbor-2" within the Specific Plan and an additional parcel located outside of the Specific Plan boundary at the southwest corner of the Seaport Boulevard/Blomquist Street intersection. The development is proposed as a high-tech office complex with four nine-story buildings encompassing 1,250,468 square feet of floor area. The development includes 4,036 parking spaces in surface and structured lots and significant landscape improvements.

Draft EIR: In accordance with State California Environmental Quality Act (CEQA) guidelines, a Draft EIR has been prepared by the City (Lead Agency) to examine the potential environmental effects of the project. The Draft EIR is intended to inform Redwood City decision makers, other responsible agencies and the general public of the potential environmental consequences associated with the project and identify mitigation measures that would reduce or eliminate those impacts. The Draft EIR evaluated the program-level impacts of the proposed Specific Plan and the project-level impacts of the proposed Harbor View Place project. The project may have significant impacts in the following areas:

- Air Quality
- Biological and Cultural Resources
- Hazards and Hazardous Materials
- Noise
- Utilities
- Transportation and Circulation

The following areas have some impacts that are significant and unavoidable even with mitigation:

- Air Quality
- Transportation and Circulation
