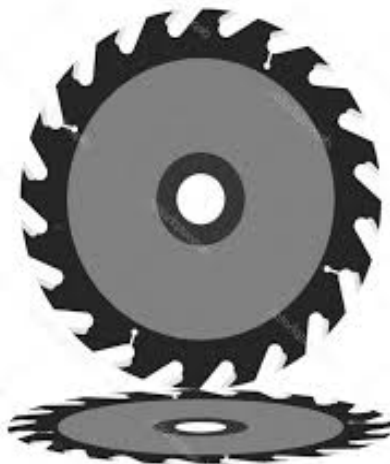


# NOISE LIMITATIONS

## UPON WORK ON PROPERTIES IN OR NEAR RESIDENTIAL DISTRICTS

### EXEMPTIONS:

Emergency work or work performed personally by the owner or resident may be performed on Saturdays, Sundays, and Holidays only from 9:00 a.m.-8:00p.m.

### NOISE PROHIBITED

MONDAYS through FRIDAYS .....8:00p.m. to 7:00 a.m.

SATURDAYS, SUNDAYS, and HOLIDAYS .....ALL DAY

*Includes any and all deliveries.*

During the foregoing periods, NO NOISE above the local ambient level in residential districts shall be generated by construction work or activities within 500 feet of any residential neighborhood.

### WORK NOISE LIMITS AT ALL OTHER TIMES:

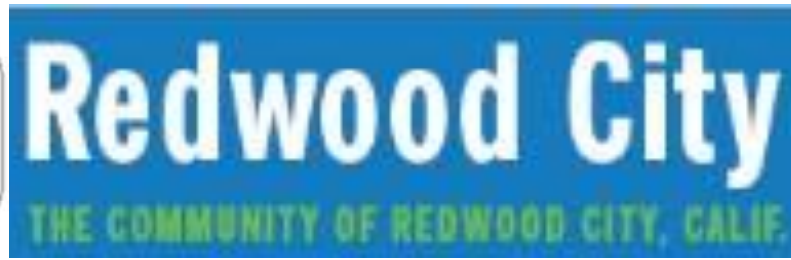
1. No individual item of machinery, equipment, or device used in or near a residential district shall produce sound in excess of 110 dBA, measured 25 feet from such machinery, equipment, or device;
2. Work noise level at any point outside of the construction site property plane shall not exceed 110 dBA within any part of a residential district.

The foregoing provisions are requirements of the *Noise Regulations* of the *City of Redwood City*, violations of which are punishable pursuant to the provisions of *Chapter 24* of the *Redwood City Code*.

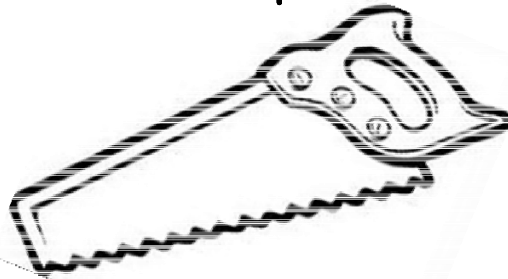

# CONSTRUCTION WORK LIMITATIONS



## CONTRACTOR WORK PROHIBITED

MONDAYS through FRIDAYS .....Before 7:00 a.m. & After 8:00 p.m.

SATURDAYS, SUNDAYS, and HOLIDAYS ..... ALL DAY

*Excludes:*

*Special work permits obtained from the City Building Division.*

### Sec. 9.45.—SECTION 110 OF THE BUILDING CODE AMENDED:

Section 110 of the Building Code is amended to add a new Section 110.1.2 to read as follows:

110.1.2 Hours of Construction. The arrival of workers and construction shall begin no earlier than 7 AM and be complete by 8 PM of each day Monday through Friday. It is prohibited for contractors to work Saturday, Sunday, or holiday periods unless they first acquire a special work permit from the Building Division. The Building Division determines holiday periods. Residential property owners may work weekends and holidays from 9 AM to 5 PM. After hours work may be performed for emergencies.
